

 ➢ 35 hired







BUFORD HIGHWAY ART

- ✓ In-person and virtual public meetings held in June 2023 to review proposed station locations (updated map). Online survey conducted.
- ✓ "Pop up" meetings continue at commercial centers and bus bays.
- ✓ Substantial completion of 30% design.
- ✓ MARTA Board approval in August 2023 allows project to move into final design.







CANDLER ROAD ART

- ✓ Avondale Station alignment is the recommended and adopted LPA.
 ✓ Public engagement held in May.
 ✓ Recommended and adopted by the
 - MARTA Board in June.
- ✓ Next steps Surveying, geotechnical work and final station design.
- ✓ Completion of preliminary design (30%) by the end of the year.





SOUTH DEKALB TRANSIT HUB


- ✓ Phase II Environmental Site Assessment was finalized at the end of June.
- ✓ NEPA/Section 106 Checklists under FTA review.
- ✓ Next steps selection of final design consultant begin real estate acquisition process.
- ✓ Estimated construction start: Jan. 2025
 ✓ Estimated construction completion: 2026





STONECREST TRANSIT HUB

- ✓ Approaching 30% design.
- ✓ NEPA/Section 106 Checklist were completed, and the project was issued a Categorical Exclusion #5.
- Phase I Environmental Site Assessment has been performed and awaiting results.
- Results from environmental work sets the stage for further design and acquisition discussion towards this property.







- ✓ Next steps: Rezoning + Phase I RFP


