

Mobility and Streetcar Ridership





MARTA RAPID A-LINE (SUMMERHILL)

- ✓ Utility work continues, paving work started between I-20 and Ormond Street
- ✓ Rapid response team presented construction updates to 9 neighborhood meetings in Q1
- Monthly community newsletter distributed
- ✓ April 10: First Coffee & Construction Quarterly event – business focus
- ✓ May 18: Summerhill route to be highlighted on Atlanta Cycling Festival's annual "Bike the Route" event





FIVE POINTS STATION TRANSFORMATION

PHASE: DESIGN, PRE-CONSTRUCTION

- ✓ The final NEPA Environmental Assessment Finding of No Significant Impact (FONSI) was signed 3/25
- ✓ Negotiating contract with Skanska
- ✓ Relocation planning for bus routes, Five Points MARTA Police Precinct, Lost & Found and HOPE Atlanta are underway







PROJECT PROGRESS: CLEVELAND AVE ART & METROPOLITAN PKWY ART

PHASE: FINAL DESIGN

- ✓ District 12 Community meeting held January 22nd at Atlanta Metropolitan Technical College to update on project nearing construction-ready status.
- ✓ Working with ATL DOT on additional scope, expect project will be re-bid late 2024/early 2025.




