Report from the Chair

Approval of the March 11, 2021 Work Session Meeting Minutes

Chair Scott called for a motion to approve the minutes. The motion to approve was made by Board Member Freda Hardage and seconded by Board Member Rod Frierson. The minutes were approved unanimously by a vote of 9 to 0 with 11 members present.^{1,2}

Report from the General Manager/CEO

2021 Legislative Session (See attached: "2021 Legislative Session): General Manager Jeffrey Parker provided an update on the recently concluded Georgia General Assembly session and legislation impacting MARTA, including:

- ➢ HB 511 − Georgia Transit Trust Fund
- Funding for Bankhead Station Expansion (\$6 million)

Bus Service Restoration Plan (See attached: "Bus Service – Full Route Restoration Communications Plan Update"): GM Parker updated the Board on the broad communications outreach effort to notify the public about the resumption of bus services on April 24. This included:

- Media engagement
- Transit advertising
- Printed collateral
- Digital & social media
- Print advertising
- Stakeholder notifications

Additionally, GM Parker clarified the following: Under regular circumstances, when MARTA makes service changes, a Title VI Service Equity Analysis is conducted and submitted to the Federal Transit Administration (FTA). However, the FTA did not require public transit agencies to conduct a Title IV analysis when making service changes due to the unprecedented impact of COVID-19. In September 2020, MARTA did conduct a Title VI analysis on the Essential Bus Service Plan and found that there was no detrimental impact to service areas. If the service changes had been in effect for a year or more, MARTA would have submitted the Title VI analysis. But because the year threshold was not met, the analysis was not submitted to the FTA.

Budget FY22 Briefing Plan and Process (See attached: "Proposed FY2022 Operating Budget Highlights"): Chief Financial Officer Raj Srinath provided an update on the FY22 budget, including key assumptions used to build the budget and remaining milestone dates before final adoption. The budget will be presented to the public on May 10 and 11. The full Board will be asked to approve the budget on June 10.

Vice-Chair Roberta Abdul-Salaam asked when will MARTA's jurisdictional partners review the proposed budget? Chief of Staff Melissa Mullinax stated this will occur during the second quarter jurisdictional briefings that are scheduled for May – before the Board's vote in June.

Board Member Al Pond asked for clarification regarding how the American Rescue Plan (ARP) funding will be split? Chief Financial Officer Srinath explained that MARTA will receive \$284 million from the ARP, which can be used for qualifying operational or capital expenditures. MARTA will utilize over 70 percent of the ARP

funding for capital purposes and use the remaining for FY22 and FY23 operating budgets.

Board Member Christopher Tomlinson asked about the timing of the jurisdictional updates and public hearings. Chief of Staff Mullinax stated that one jurisdictional meeting will occur before the public hearings and the remaining jurisdictional briefings will occur after the public hearings but before the Board budget vote in June.

Board Member Tomlinson also asked how the federal rescue plan funding will be utilized. Per Chief Financial Officer Srinath:

- > Coronavirus Aid, Relief, and Economic Security (CARES) Act
 - MARTA received \$288 million
 - Allocated the amount across FY20, FY21, and FY22
- Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA)
 - MARTA received \$33.5 million
 - Applied the entire amount to the capital budget
- > American Rescue Plan (ARP) Act
 - MARTA received \$284 million
 - Over 70 percent will go towards the capital budget
 - The remainder will be applied to portions of FY22 and FY23 budgets

Board Member William Floyd asked about the sales tax revenue forecast. Per Chief Financial Officer Srinath:

- ➢ In FY22
 - \$557.8 million collected
 - 3.2 percent increase over FY21
- ➢ In FY23
 - Expect \$601 million to be collected
 - 7.8 percent increase over FY22

Board Meetings Virtual to In-Person Transition (See attached: "Eventual Transition: Virtual to In-Person"): Chief of Staff Mullinax discussed what Board Members could expect when in-person meetings resume. As well, she explained that the Georgia General Assembly passed House Bill 98, which allows cities and authorities to declare their own state of emergency and therefore conduct virtual public meetings. At the time of the April 9 Board meeting, the Governor had not signed the bill into law.

Board room has been outfitted with anti-COVID-19 measures. As well, new audiovisual equipment has been installed in the Board room to allow for live streaming of meetings.

Board Member Floyd inquired as to the definition of a public meeting. Chief of Staff Mullinax stated that both the Open Meetings and MARTA Acts define this. She also stated that the ACCG has created a guide to the Open Meetings Act that will be distributed to Board members.

Chair Scott asked if the Governor has signed HB 112 regarding COVID-19 liability claims. Chief Counsel Elizabeth O'Neill said she would check on the status of the bill.

Board Member Frierson asked about how the public would be accommodated once the Board room is at capacity. Chief of Staff Mullinax stated that there are locations in the Headquarters building where overflow can be accommodated. Also, there will be multiple ways the public will be able to submit their comments.

Vice Chair Abdul-Salaam asked if Board members will be provided hard copies of the FY22 budget prior to the Board briefing on May 5. Chief of Staff Mullinax responded affirmatively.

Vice Chair Abdul-Salaam also asked if all meetings – including Committee meetings – will be live-streamed. Chief of Staff Mullinax stated that they will be.

Chair Scott asked if seniors who are not computer savvy will have a way to submit public comment. Chief of Staff Mullinax stated that a phone number is already available for the public to leave a message with their comments. And staff will be on hand to assist those individuals using iPads to leave a comment when they attend a Board meeting in person.

2 Significant Wins

- \$6 Million for Bankhead Station Expansion
- HB 511 Creation of the Georgia Transit Trust Fund

Following on the passage of Constitutional Amendment #1 by Georgia voters in November 2020, fees from the for-hire-ground transportation excise established by HB 105 late in the 2020 Session will be eligible to any transit agency in the state for transit capital projects, subject to appropriation by the Legislature.

PROPOSED FY2022 OPERATING BUDGET HIGHLIGHTS





Key Assumptions

Supports MARTA's Strategic Priorities

- Consistently provide excellence in customer service
- Deliver the capital program with speed and efficiency
- Demonstrate fiscal responsibility
- Strengthen the MARTA brand

Utilized the March 1, 2021 Sales tax Forecast provided by GSU Economic Forecasting Center. FY22 fare revenues assumed to be \$60.3M (FY21 fare revenues forecasted to be \$44.1M)

Non-Represented employee wage increase of 3% on average assumed. Represented employee raise assumed consistent with the current contract

All CRRSAA Funding (\$33.5M) is applied to Capital Budget

American Rescue Plan funding split \$84M for the Operating Budget and \$200M for the Capital Budget

FY22 Operating Budget will be at or below FY21 Operating Budget

Current Governing Regulation

Governor Kemp's Public Health State of Emergency extended to April 30, 2021.

Allows MARTA Board meetings and public hearings to be held virtually.

MAY be extended beyond April 30.

If not extended, standard Open Meetings laws apply.





New Legislation – HB 98

HB 98/AP

House Bill 98 (AS PASSED HOUSE AND SENATE) By: Representatives Lumsden of the 12th, Blackmon of the 146th, Fleming of the 121st, Oliver of the 82nd, Williamson of the 115th, and others

A BILL TO BE ENTITLED

AN ACT

1 To amend Title 50 of the Official Code of Georgia Annotated, relating to state government,

2 so as to provide conditions for meetings and public hearings to be held by teleconference in

3 emergency conditions; to provide for related matters; to provide for an effective date; to

4 repeal conflicting laws; and for other purposes.

5 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

SECTION 1.

7 Title 50 of the Official Code of Georgia Annotated, relating to state government, is amended

8 by revising subsection (g) of Code Section 50-14-1, relating to meetings to be open to public,

9 limitation on action to contest agency action, recording, notice of time and place, access to

- 10 minutes, and teleconference, as follows:
- 11 "(g)(1) As used in this paragraph, emergency conditions shall include declarations of
- 12 federal, state, or local states of emergency; provided, however, that no such declaration
- 13 shall be necessary for an agency as defined by subparagraph (A) of paragraph (1) of
- 14 subsection (a) of this Code section to find that emergency conditions exist thereby
- 15 necessitating meeting by teleconference.




